## **Construction Around Our Campus and Student Safety**

As you all know, there is a lot of construction happening on our campus and on Tonopah Avenue in front of our school. We know all this construction makes dropping off and picking up your student(s) challenging. Thank you for being patient and safe when driving and/or walking to and from school.

During drop off in the morning and dismissal after school, please continue to avoid the bus lane and parking lot on the east side of campus near the Multipurpose Room. We need to keep the space where buses load and unload clear for the safety of all.

Additionally, please only have students cross Tonopah Avenue in front of the Multipurose Room where the crossing guard is. Having students cross outside of this new crosswalk is unsafe. Thank you for your assistance with this matter.

## **CCSD Regulation 4100**

The Clark County School District (CCSD) continues to develop plans and resources to ensure the safety of students and create policies that ensure appropriate relationships maintained between students and staff. In the fall of 2017, the Board of School Trustees adopted Regulation 4100, and CCSD has established new procedures for campus safety and background checks for volunteers on campus.

Regulation 4100 addresses many items, including appropriate online communication between employees and students, parameters for employees to set with students to create caring, trusting relationships with appropriate boundaries, and implementation of a new state fingerprinting law for volunteers on all CCSD campuses. In this new state law, volunteers who spend four (4) or more days a month on campus volunteering are now required to get fingerprinted and complete a full background check in order to volunteer on campus. If you are hoping to volunteer on campus, please come speak with the front office for more information.
